A. Revision of Policy 5.17-Reduction-in-Force & Policy 4.15-Title IX

Dr. Reyes shared with the Board that he along with our Board attorney, Mr. Taylor Brooks, Mr. Kevin Willoughby and Mrs. Sheila Cornelison have worked on the revision of Reduction-in-Force policy that is much stronger than the original policy. He stated that he doesn't see that our school system will have to do a reduction-in-force. Dr. Reyes also stated that our Board attorney, Mr. Taylor Brooks, reached out to him in regard to the new language in the Title IX policy and suggested that our Title IX policy be revised. He shared that the policies will be discussed at a later time and would need to lie on the table for 30 days before being voted on.

B. New Policy – Policy 6.25-Supervision of Low Risk Juvenile Sex Offenders

Dr. Reyes shared with the Board that Policy 6.25 is a new policy that AASB recommended to be adopted by the Board.

Dr. Reyes talked with Board about stipends for virtual teachers. He also had Mr. Paradise share with the Board the process and difficulty of scheduling for the high school for the 2020-2021 school year.
