As recommended by Dr. Reyes, a motion was made by Mr. Williams and a second by Mr. Woosley to approve the Mask Ordinance that Scottsboro City Schools adhere to the Governor's ruling to allow the choice to mask or not to mask for faculty, staff, and students at the cessation of the current order ending on April 9, 2021 for the remainder of the 2020-2021 school year. A roll call vote was taken with a yes vote by Mr. Benson, Mr. Williams and Mr. Woosley and a no vote by Mrs. Stewart and Dr. Speers. The motion was approved.

Information

A. COVID Update

Dr. Reyes gave an update COVID cases for Scottsboro City Schools Cases. There have been zero positive cases for faculty and students for the past six (6) weeks. There is still 50% of staff who have taken the vaccine and 50% who have not.

B. Scottsboro High School Prom

Dr. Reyes shared information is planned for April 17, 2021 from 7:00 p.m. – 11: 00 p.m. at Goosepond Civic Center and is restricted to students of Scottsboro High School only.

C. End-of-Year Activities

Dr. Reyes shared that the End-of-Year Activities is provided for them and if they can attend some of these activities, especially the ones for Seniors, that would be good.

Dr. Reyes also shared with the Board that he has been thinking about for quite a while about hiring a system wide Strengthening/Conditioning Coach and has talked with Mr. Paradise about this position. He stated that our system is in good shape financially and would like for this to be on the next work session agenda for discussion.

The USDA came and looked at the baseball/softball fields and there will be a group that will come in and do a core sample on the fields and it will cost about \$8,500. We need to find out what is wrong with the fields before going any further
