

Board Meeting  
December 12, 2011

The Scottsboro City Board of Education met in regular session on the above date at 5:00 P.M. at the Page Administration Building with all members present: Mr. Robbie Copenhaver, Mr. Jerry Coleman, Mr. Daryl Eustace, Dr. Judy McCrary, and Mrs. M.M. McKinnon.

Mr. Copenhaver, Board President, called the meeting to order.
