

Board Meeting
May 3, 2010

Before adjourning, Dr. Berry requested that Cynthia Patridge, Media Specialist at Collins Elementary School, share with the board the good news she received in regard to a grant the school has received from Home Depot. In the fall of 2009, Collins Elementary School received a \$2,000 grant for the library. She was contacted in the spring of 2010 by Home Depot requesting she submit a presentation regarding the library project. The presentation also included pictures of the project and comments from Collins Elementary teachers and students with reference to the improvement in the library. This was submitted by Home Depot to the home office along with photographs they had taken. Home Depot was notified today that the Scottsboro store along with another store in the United States had tied and the library at Collins Elementary School would receive a \$4,000 grant and the store would receive \$2,000. This was a United States wide competition.
