

Board Meeting
August 30, 2010

The Scottsboro City Board of Education conducted the first public hearing regarding the FY2011 Budget at 4:30 P.M.

They will be recognized at the Alabama Association of School Board's Convention in December.

Dr. Berry presented Mr. Hodges with a Date Plate for completion of Master Second Year of the Alabama Association of School Board's Academy.
