On the superintendent's recommendation regarding **Roofing and Water Infiltration Project at Scottsboro High School**, a motion was made by Dr. McCrary and a second was made by Mr. Coleman to approve. A vote was taken for the motion to table the recommendation with a no vote by Mr. Copenhaver, Mr. Coleman and Mrs. McKinnon and a yes vote by Mr. Eustace and Dr. McCrary. Mr. Copenhaver called for a vote on the recommendation and a yes vote was made by Mr. Copenhaver, Mr. Coleman and Mrs. McKinnon and a no vote was made by Mr. Eustace and Dr. McCrary.

Dr. Berry introduced Senator Barron who addressed the board in regard to his recent conversation with Dr. Berry in regard to her interest in bringing the board into modern technology with the use of the I-Pad for board meetings. He shared that he would contribute a check in the amount of \$3,000 to go toward the expense of purchasing I-Pads.
