These phones were blackberries that were purchased last year for the administrators. able to renew with a \$30 purchase of the equipment. Because of this, we will offer the old phones at the cost of \$30. Dr. Berry told the board members if they were interested in purchasing one of these phones to contact Alan Garner.
