Board Meeting July 14, 2008

The Board of Education conducted the first public hearing regarding the FY2009 Budget at 4:30 P.M.

The Scottsboro City Board of Education met in regular session for the July board meeting on the above date at 5:00 P.M. in the Page Administration Building with the following members present: Mr. Jerry Coleman, Mr. Donald Hodges and Mrs. M.M. McKinnon. Dr. Judy McCrary and Mr. Howard Hill were absent.

In the absence of Dr. Judy McCrary, Mr. Jerry Coleman, Vice-President, conducted the meeting.

On a motion from Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to approve the **Agenda** with the addition of recommendation of Salary Schedules.

The board members received a copy of **Policy D10C** – **Bidding Requirements** at the June 2, 2008, board meeting, but changes were made in the wording in order for the policy to be more in compliance with the law. Dr. Berry requested that this policy be voted on tonight in order for it to be in effect August 1, 2008, and not allow the policy to lie on the table for 30 days. On a motion by Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to set aside the 30-day rule in regard to **Policy D10C** – **Bidding Requirements**.

On a motion by Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to approve **Policy D10C – Bidding Requirements.**

On a motion Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to approve the **Out-of-District School Attendance Waiver** for two (2) students to attend Caldwell Elementary School. Dr. Berry explained that this was not a request by the parent. This is a parent who is working with us. We have a student at Brownwood Elementary who has a medical condition that required he be in a school where there was a nurse so that if anything happened the nurse could take care of him within two (2) minutes. The sister (kindergarten 2007-2008) of this student was already in school and he will be a kindergarten student beginning with the 2008-2009 school year. Dr. Berry met with the mother and requested if she would consider putting her children at Caldwell Elementary if she didn't agree to place them at Caldwell Elementary. The mother was glad to do this. If in the future we should have other students who would require a nurse, these students could go back to Brownwood Elementary.

On a motion by Mr. Hodges and a second by Mrs. McKinnon, the vote was unanimous to approve the purchase of the **Microsoft School Agreement** (renewal of Microsoft license) from CDW-G at a cost of \$39,167.06 for the 2008-2009 school year.

On a motion by Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to approve the **Salary Schedules for 2008-2009.** Connie Roberts told the board members that the first five (5) pages on the salary schedules were the ones that were affected by the changes. Most of the changes were not in regard to salaries but include the following: 1) Bus Driver to include the tech school route for cosmetology, 2) Maintenance/Transportation-added supervisor and assistant supervisor for anyone hired after July 1, 2008, would be placed on this schedule not on the old one, 3) Secretaryadded a nine (9) month, Associates Degree, 4) Transition Job Coach, Parental Involvement/Community Ed-added a nine (9) month salary due to an employee who wanted to go from a twelve (12) month contract to nine (9) month contract, and 5) the Substitute Teacher pay had to be increased to be in compliance with the Federal Minimum Wage Requirement.

Dr. Berry presented a certificate to board member, Mrs. McKinnon, for completion of level 2 and 3 of the Alabama School Board's Academy. She noted that Mr. Coleman and Mr. Hill have completed all levels and that Mr. Hodges has completed to level 4. The higher levels will be recognized at the summer meeting.

On a motion by Mrs. McKinnon and a second by Mr. Hodges, the vote was unanimous to Adjourn.
