

Board Meeting
October 6, 2008

The Scottsboro City Board of Education met in regular session for the September board meeting on the above date at 5:05 P.M. in the Page Administration Building with the following members present: Mr. Jerry Coleman, Mr. Robbie Copenhaver, Mr. Donald Hodges, Dr. Judy McCrary and Mrs. M.M. McKinnon.
