

Board Meeting  
September 18, 2006

The Scottsboro City Board of Education met in regular session on the above date at 6:00 P.M. in the Page Administration Building with all members present: Mr. Jerry Coleman, Chairman, Mr. Howard Hill, Mr. Donald Hodges, Dr. Judy McCrary and Mrs. M. M. McKinnon.

M. M. McKinnon, new Board Member for Place #1, was sworn in by Judge Jennifer Holt.

On a motion from Mr. Hill, seconded by Dr. McCrary, the vote was unanimous to approve the **agenda**.
